

## **Privacy Statement**

Friends of PATA Manzanillo is committed to protecting your privacy. This Privacy Statement applies to the Friends of PATA Manzanillo web site and governs data collection and usage. By using the Friends of PATA Manzanillo website, you consent to the data practices described in this statement.

### **Collection of Your Personal Information**

Friends of PATA Manzanillo collects personally identifiable information, such as your email address, name, home or work address or telephone number. Friends of PATA Manzanillo may also collect anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Friends of PATA Manzanillo. This information can include: your IP address, browser type, domain names, access times and referring web site addresses. This information is used by Friends of PATA Manzanillo for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Friends of PATA Manzanillo web site.

### **Use of your Personal Information**

Friends of PATA Manzanillo collects and uses your personal information to operate the Friends of PATA Manzanillo web site and deliver the services you have requested. Friends of PATA Manzanillo may also use your personally identifiable information to inform you of other products or services available from Friends of PATA Manzanillo. Friends of PATA Manzanillo may also contact you via surveys to conduct research about your opinion of current activities or of potential new campaigns that may be offered.

Friends of PATA Manzanillo does not provide its member lists to third parties under any circumstances. Friends of PATA Manzanillo may share data with trusted partners to help us perform statistical analysis, send you email, or provide customer support. All such third parties are prohibited from using your personal information except to provide these services to Friends of PATA Manzanillo, and they are required to maintain the confidentiality of your information.

Friends of PATA Manzanillo does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Friends of PATA Manzanillo may publish the name of you, your organization, institution, or firm, but will not link such information to your personally identifying information.

Friends of PATA Manzanillo keeps track of the web sites and pages our customers visit within Friends of PATA Manzanillo, in order to determine which Friends of PATA Manzanillo pages are the most popular. This data is used to evaluate the content within Friends of PATA Manzanillo and adjust based on visitor visits.

Friends of PATA Manzanillo web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Friends of PATA Manzanillo or the site; (b) protect and defend the rights or property of Friends of PATA Manzanillo; and, (c) act under exigent circumstances to protect the personal safety of users of Friends of PATA Manzanillo, or the public.

## **Use of Cookies**

The Friends of PATA Manzanillo web site currently does not use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

You have the ability to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of web sites you visit.

## **Security of your Personal Information**

Friends of PATA Manzanillo secures your personal information from unauthorized access, use or disclosure. Friends of PATA Manzanillo secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other web sites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol. Credit card numbers are not transmitted to Friends of PATA Manzanillo, and are not retained by Friends of PATA Manzanillo.
